

TERMS AND CONDITIONS OF TRADING AGREEMENT

NAME OF TRADER:

THIS DEED is made the day of 20.....

BETWEEN AUCKLAND FOLK FESTIVAL (INC)
(hereinafter called "Auckland Folk Festival (Inc)")

AND
(hereinafter called the "Trader")

WHEREAS

The Trader wishes to sell their goods to the patrons of Auckland Folk Festival at the annual Folk Festival held at Kumeu.

The parties wish to record the terms of their agreement

The execution of this agreement by the Trader constitutes the Trader's agreement to be bound by this agreement.

NOW THE PARTIES AGREE AS FOLLOWS:

- The Trader must have prior approval to trade in writing from the Auckland Folk Festival (Inc).
- The Trader must set up in the area designated on the site map.
- The Trader must not sell food and beverages. There are separate and specific conditions for food Traders
- The Trader must keep their stalls and surrounding area tidy, rubbish to be placed in the bins
- The Trader must act in a safe, respectful and responsible manner at all times and not block any access.
- The Trader must comply with all request made by the Site Manager.
- Religious and or Political material may not be circulated or included with goods
- PA's and Sound systems are not permitted by the Trader in the Market area.
- Traders not complying with any of these Terms and Conditions may be asked to leave the Festival site.
- The Trader agrees to be bound by the Terms and Conditions of Entry set out in the Registration Form for Festival patrons (copy attached).
- The Trader hereby jointly and severally indemnifies and saves harmless the Auckland Folk Festival(Inc.) and it's trustees from and against any loss, costs or damages (whether direct or indirect) in any way arising out of the Traders business or use of the site at the Kumeu Showgrounds to sell goods to patrons of the Auckland Folk Festival
- This indemnity is absolute and unconditional, and the obligations of the Traders shall not be released, discharged, modified, impaired or affected in any manner whatsoever.
- Auckland Folk Festival (Inc.) shall not be liable to the Trader for any loss of profit, loss of business or consequential loss of the Trader, howsoever caused.
- This Agreement is governed by the laws of New Zealand.
- This Agreement will come into force when both parties have signed it.
- This Agreement is acknowledged as a legal document.
